GENERAL DESCRIPTION :

proTico cleaner glue liquid and proTico cleaner glue gel are a powerful remover that removes residues from many glues, paint or varnish on horizontal and vertical surfaces. Ecological and biodegradable product of last generation formulated in compliance with the legislation, the environment as well as for the user.

APPLICATION DOMAIN :

proTico cleaner glue in gel version was formulated for a perfect efficiency and holding of the product on the vertical surfaces having residues of adhesives, paints or varnishes. Developed for the proTico process but also usable for other applications such as the removal of carpets, requiring the removal of glues of types: neoprene, vinyl, acrylic, hotmelt...

USER MANUAL :



Ready to use after stirring the jerrican, proTico cleaner glue liquid or gel apply with a low pressure or roller sprayer. Coat the surfaces to be cleaned uniformly and allow the product to act a few minutes after the thickness of the adhesive to be softened, on average 15 to 45 minutes. For paints and varnishes the time of action to curl the paint will be 1 to 6 hours depending on the formulation of the product. Remove the residue with a rubber squeegee or metal spatula.
